Energy Star® Windows Rebate El Paso Electric



Texas Residential & Income Qualified Solutions Programs

1. Program Overview

- El Paso Electric will pay out a rebate to eligible customers within EPE's Texas service territory that install Energy Star® windows, Energy Star® storm windows or solar screens.
- Rebates will be available through December 31, 2025, or upon funding availability.
- Customers will reserve funding with El Paso Electric prior to purchasing the unit and will have 45 days to complete the project (See additional information under #4. Reserve Funding below).
- Customers may hire a contractor of their choice, or they may choose to do the work themselves.
- Rebate amount depends on total square footage of windows installed
- Rebates **up to \$1.35 per sq.ft**. (this example applies to a home with single pane windows and refrigerated air cooling)
- If total project cost is less than the calculated rebate amount, the rebate will equal the total project cost.

2. Customer Eligibility

- Customer must reside in Texas and receive electric service from EPE (Except Culberson County).
- Single Family Homes only (1-4 units in one location).
- To qualify for enhanced incentives through our Income Qualified Energy Efficiency Program check the Income Eligibility Form found at https://epesavings.com/residential-lowincome.html
- Customer must qualify through categories 1A, 1B or 1C. Category 2 is not eligible.
 - Category 1A Provide proof.
 - Category 1B Confirm during funding reservation.
 - Category 1C Check at <u>www.huduser.gov/portal/sadda/sadda_qct.html.</u>

3. To Qualify

- New windows must comply with the latest ENERGY STAR® code https://www.energystar.gov/productfinder/
- New windows must have a U-Factor ≤0.28 and SHGC ≤0.23
- Solar screens must be installed on windows facing south or west and must block at leas 65% of solar heat gain.
- Solar screens is only eligible for homes with refrigerated air cooling.
- Storm windows must have Emissivity ≤ 0.22 and Solar Transmission ≤ 0.55

4. Reserving Funding

- Please call El Paso Electric at 915-521-4488 to reserve funding prior to purchase of unit.
- This program has limited funding. Once all funding is reserved, a waitlist will be opened.

5. Submit Required Documentation for Payment of Project

- Submittals will be made through email at epe.residential@clearesult.com or mail to CLEAResult at 311 Montana Ave. A-2 El Paso, TX 79902.
- Customer must submit the following documents within the 45-day period started from when the customer first reserved funding.
 - Application Form.
 - Existing windowpane, window sizes, orientation of windows with new solar screens, equipment ratings.
 - Release of liability for both El Paso Electric and CLEAResult included.
 - Photographs of removed windows, photographs of new windows, photographs of stickers showing U-factor & SHGC, or Emissivity & Solar Transmission,
 - Copy or photograph of invoice or receipt.

6. Project Notification/Schedule Inspections

Once the rebate application is submitted, El Paso Electric and/or CLEAResult will perform an
inspection to confirm project completion before paying out incentive. Inspections take 15 to 20
minutes and are scheduled during office hours; M-F, 8:00 am – 5:00 pm.
